Please read this form carefully. PLEASE PRINT CLEARLY and fill in entirely. Please make sure the form includes the parent/guardian signatures and initials on both pages. USA HOCKEY REGISTRATION:

All players are required to register online at www.usahockey.com for the 2009/2010 Season and provide a registration confirmation number to the registrar prior to tryouts.

BIRTH CERTIFICATES:

A birth certificate copy is required for all new and returning players. This must be given to the team manager before the first practice to be verified. The Team Manager will create and retain a notarized list of birth certificate verifications in the team's Manager's Book.

PLAYER AND PARENT CODE OF CONDUCT:

1. Comments that are negative in nature will not be directed toward any referee, opposing player or team member.
2. Concerns regarding your child's team should be addressed directly with your child's coach/assistant coach at the proper time and place. Please do not discuss issues during games or immediately thereafter. Allow a 24-hour "cooling off" period.
3. The highest standards of sportsmanship will be evident at all GYHA functions. Any negative behaviors, which include but are not limited to, derogatory comments directed toward opposing players, refusal to shake hands at the end of games, use of tobacco products, alcohol and drugs of any form can result in a child's suspension from GYHA.
4. Concerns regarding GYHA should be documented in writing and sent to GYHA to the attention of the Board of Directors.
4. Any breach of the above standards of conduct by a player or his/her parent(s) may result in your child's suspension and removal from GYHA. Comments and behaviors of any player or parent that contradicts the mission statement, disrupts the functioning of a team or GYHA may result in suspension and/or removal from GYHA, on the recommendation of the Hockey Director and the Board of Directors.
5. Each parent is required to register online www.caha.pucksystems2.com to complete the CAHA Cares Program recommended by USA Hockey and endorsed by GYHA.

REFUND POLICY:

Tryout, Registration and League fees are non-refundable except in a case-by-case review of a season-ending injury. Please refer to the GYHA by-laws for this information.
